After nomination by President George W. Bush and confirmation by the United States Senate, I served as the chief executive officer of an independent federal agency whose missions are to engage Americans in meeting unmet domestic needs through voluntary service and to renew the ethic of civic responsibility in the United States. The Corporation operates three major programs: AmeriCorps, Learn & Serve America, and Senior Corps. It has a budget of approximately \$1 billion and employs over 600 people, with offices in Washington and every state. Close to two million Americans are estimated to be involved in its programs.

As CEO, my major accomplishments have been to build bipartisan support for the Corporation's programs, address longstanding management problems, and help launch a major Presidential initiative aimed at promoting voluntary service, with a special focus on homeland security. I have worked closely with senior officials in the Executive Office of the President and several Cabinet departments. I have testified numerous times before Congressional committees, as well as met regularly with individual

members of Congress. I have addressed the National Press Club, the City Club of Cleveland, and many other organizations, as well as been interviewed frequently by print and broadcast journalists.

As a member of the faculties of the College of Liberal Arts and School of Public and Environmental Affairs, I was responsible for teaching, research and writing on a wide range of topics for both scholarly audiences and the general public. I was also a research associate of the Indiana University Center on Philanthropy, a twelve-year-old organization that seeks to improve research and teaching about, as well as the practice of philanthropy. I taught three graduate-level courses per year, plus an executive education course through distance learning. I served as advisor to numerous M.A. and M.P.A. candidates, as well as to two Ph.D. candidates.

In the summer of 1999, I created the Institute on Philanthropy and Voluntary Service, a unique program for undergraduates from throughout the United States who lead campus service programs. I chaired the Academic Program Committee of the Philanthropic Studies faculty and served on the Academic Affairs Committee of the College of Liberal Arts, among other faculty responsibilities. I was on course to receive tenure when I took leave from the university for government service.

Hudson Institute is a thirty-year-old research organization that conducts studies and related activities on a wide range of domestic and international public policy issues. The President is the Chief Executive Officer and responsible for all aspects, including fund-raising, of this \$7 million, 80-employee organization.

Major accomplishments included doubling the institute's budget, developing new programs in education, welfare, and regulatory policy, launching the institute's first capital campaign, and recruiting several prominent researchers and trustees.

The Institute for Educational Affairs was a non-profit organization that assisted foundations, corporations, and individuals with their grant-making activities, especially with regard to higher education. As Chief Executive Officer, the President was responsible for all aspects of its program and administration. Reporting directly to the Board of Directors, the President's duties included fund-raising, program development, supervision of grants for work in higher education, journalism, public policy and other areas, maintenance of a network of grant-makers, public relations, and assuring compliance with pertinent legal and fiscal standards.

Major accomplishments included leading the institute through a period of major reorganization, increasing its budget by 33 percent, and expanding its major programs. Upon my leaving, the institute was merged with another organization.

Under a broad delegation of responsibility and authority from the Director of the Agency, the Deputy Director was charged with implementing the Administration's policies through oversight and direction of USIA operations, personnel, and facilities in the United States and abroad.
